Glendive Medical Center (GMC) is pleased to share this Community Benefit Report with you. It highlights our achievements over the last year. GMC is committed to be the provider of choice for quality health care in the region.

In September, the GMC Board of Directors and Billings Clinic finalized the affiliation agreement. We are looking forward to working more closely with Billings Clinic to recruit physicians and expand access and services for the Glendive region.

We also announced the new GMC Chief Executive Officer (CEO), Parker Powell, in September. We believe he is a great fit for GMC and are confident that Parker has the vision and skills to lead GMC as we work together with Billings Clinic to improve and grow quality healthcare options.

In June, GMC began a partnership with Ortho Montana. We are working with them to aggressively recruit an orthopedic surgeon. Until a permanent surgeon is recruited and established, Ortho Montana will continue providing interim orthopedic services on a rotating basis.


Words of Appreciation from a Patient

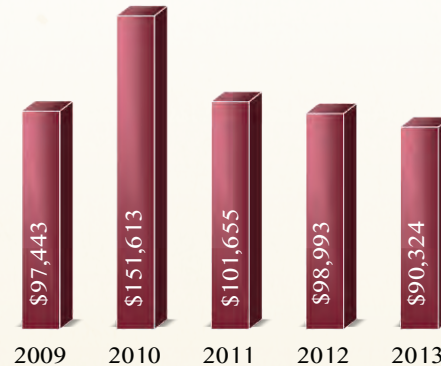

Partnering with Ortho Montana

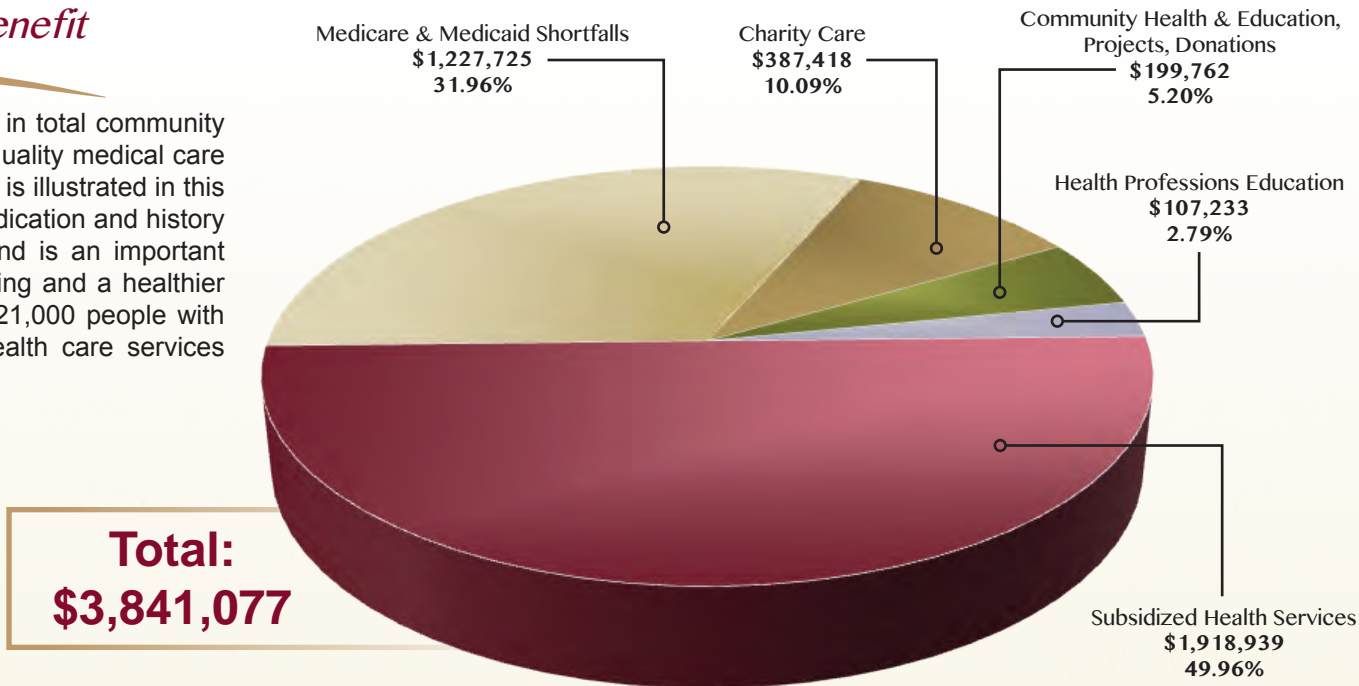

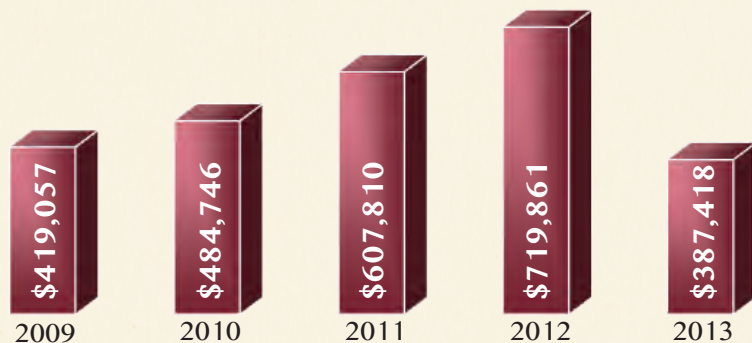
GMC's Total Community Benefit

Charity Care

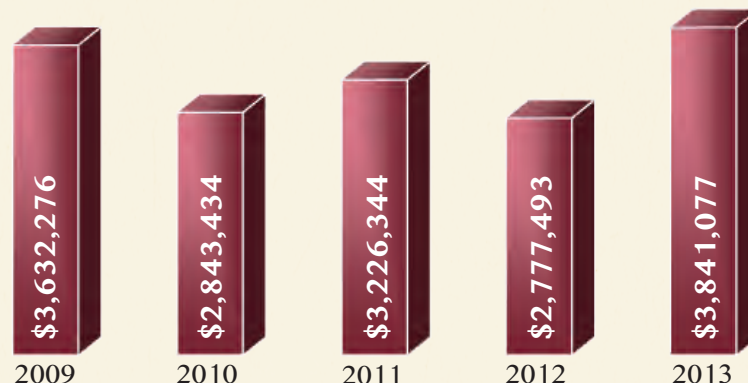
